Proposed Changes to the School Day Notification to Stakeholders and Consultation Process

5th April 2019

Dear Parents/Carers

We are writing to you on behalf of the Board of Trustees, concerning a proposal to change the timings of the school day, so that you can take part in the consultation process. You may be aware that a number of schools are making similar proposals, with many schools having already implemented such changes.

Some Background Information

All teachers are legally entitled to 10% of their teaching timetable for 'non-contact time', in order to plan, mark and prepare work on a weekly basis. This time is called PPA (Planning, Preparation and Assessment).

Every week, a teacher needs to have approximately 2.2 hours of PPA when the class is covered by another member of staff.

Educational Considerations

This means that some release time is taken during the afternoon, which does not interrupt the English and Maths teaching in the morning, but some PPA has to be timetabled for the morning sessions, which means that English and Maths are either taught by a different teacher that day, or taught during the afternoon.

What impact does this have on children's learning?

Covering PPA interrupts the flow of teaching in English and Maths during the mornings. Research shows that pupils are better learners in the morning and therefore, it is better to teach core lessons in the mornings.

Financial Considerations

Having outlined educational considerations, it is very important to note that the main and essential consideration is that of the school's financial position. The current method of enabling teachers to have their PPA time costs a very significant amount of money. Costs for schools have continued to increase whilst budgets have remained frozen. In real terms this means that many schools nationally, including Westminster, have suffered budget cuts. Figures from the Institute for Fiscal Studies show that school funding has been cut by 8% in real terms, since 2010. If we do not make substantial changes now, we would soon be in

the situation of a large deficit budget. This is not acceptable, as it would mean we would no longer be financially viable as a school.

The Proposal

We are proposing that PPA should be taken on Friday afternoons and that the school day ends at the earlier time of **12:30pm on Fridays**, which will eliminate the need to arrange cover during the week.

- All teachers will be able to work together more closely to plan the best possible lessons.
- This will increase the consistency and quality of teaching in English, Maths and across the curriculum, impacting on standards across all subjects.
- Cost savings keep our school viable, continuing to provide a great education for our children.
